2. Hazards Identification

Emergency overview: Caution. May cause irritation to skin and eyes. May be harmful if swallowed.

EYE CONTACT : Can cause irritation, redness, tearing.

4. First Aid Measures

EYES: Immediately flush eyes with a direct stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Get medical attention.
